1. Name of Club

The name of the Club shall be "East Down Yacht Club".

2. Objects of the Club

To promote the sports of sailing, rowing and canoeing in Strangford Lough and elsewhere throughout Northern Ireland, and such other sports and activities as the Executive Committee shall consider consistent with the welfare of the Club, and to instruct people in such sports. In all cases, preference will be given to sailing crafts. The use of PWCs (Personal Water Craft) shall not be permitted at the club.

3. Club Policies

3.1 Child Protection Policy

The Club has adopted and is committed to observing the Child Protection Policy set out in Appendix A to the Club Rules and recognises its responsibilities under the Child Protection (Northern Ireland) Order 1995. At all times members in contact and working with young people on courses and in events organised by the Club shall observe the Code of Conduct set out in Appendix B to the Club Rules.

3.2 Health & Safety Policy

The Club has adopted and is committed to observing the Health & Safety Policy set out in Appendix C to the Club Rules.

3.3 Equality Statement

The Club has adopted and is committed to observing the Equality Statement set out in Appendix D to the Club Rules.

3.4 Data Protection Policy

The Club has adopted and is committed to observing the Data Protection Policy as set out in Appendix E to the Club Rules.

4. Affiliation to Royal Yachting Association

The Club shall be affiliated to the Royal Yachting Association.

5. Officers of the Club

The following Officers shall be elected annually by the voting members at the Annual General Meeting: Commodore, Vice Commodore, Rear Commodore (Sailing), Sailing Captain, Honorary Secretary, Honorary Treasurer. No one person may be elected as Commodore for more than three consecutive occasions and no one person may be elected as Vice Commodore for more than three consecutive occasions.

6. Nomination for Election to Executive Committee

Nominations for all elected offices and posts should be lodged in writing with the Honorary Secretary not later than five days prior to the Annual General Meeting. Each nomination shall be signed by a Proposer and by a Seconder, and shall bear the signature of the Nominee as an indication of his or her willingness to serve on a committee, if so elected. Nomination forms shall be made available to members at the appropriate time. All Nominees, Proposers and Seconders must be fully paid up adult voting members. Nominees for Commodore and for Vice Commodore must have served on Executive Committee, prior to nomination. If the number of nominations received by the due date is fewer than the number of offices and posts to be filled, then the Chairman of the Meeting may, provided the Meeting approves, seek nominations for those specific offices and posts which are deficient. All three parties to any such nomination must be present.

7. Taking of Minutes

The Honorary Secretary shall keep a record of the proceedings at the Annual General Meeting and the Executive Committee meetings and shall see that the decisions of these Meetings are implemented.

8. Accounting

The Honorary Treasurer shall be accountable to the Executive Committee for the receipt and payment of all money due to or owing by the Club and shall keep correct accounts and books showing the receipts, expenditure and financial affairs of the Club, audited yearly by the Honorary Auditor before they are presented to the Annual General Meeting. The Honorary Auditor shall be appointed by the Executive Committee and need not be a Member of the Club.

9. Executive Committee

The affairs of the Club shall be the responsibility of the Executive Committee, which shall consist of the Officers specified in Rule 5. In addition, four members shall be elected annually at the Annual General Meeting to serve on the Executive Committee. The Executive Committee shall meet from time to time at such place and hour as may be convenient and as summoned in writing by the Honorary Secretary. A guorum of half of the members of the Executive Committee shall be required to conduct business. In the event of a voting tie, the Chairman shall have a casting vote. The Executive Committee may appoint sub-committees to deal with any special business, provided that the power of the Executive Committee to elect or reject members shall not be delegated to any other committee. In the event of a vacancy occurring in the Executive Committee during a current year of office the Executive Committee may, at its discretion, appoint a successor, who shall hold office until the next Annual General Meeting. The number of successors so appointed shall not exceed two in any one year. If necessary a Principal Training Officer, a Principal Race Officer, an Assistant Honorary Secretary and/or an Assistant Honorary Treasurer may also be appointed by the Executive Committee at any time during the year. All such persons shall not by virtue of such appointment be members of the Executive Committee. The Commodore, the Vice Commodore, Principal Training Officer and the Principal Race Officer shall be ex officio members of all other committees.

10. Sailing Committee

The Sailing Committee shall consist of the following: Rear Commodore (Sailing), Sailing Captain, Cruising Captain, Youth Coordinator, four members elected annually at the Annual General Meeting, and a maximum of four members appointed by the Executive Committee at its first meeting following the Annual General Meeting. The Sailing Committee shall meet regularly to consider any duties assigned to it by the Executive Committee, and to provide reports and recommendations to the Executive Committee. The Sailing Captain shall ensure that proceedings are minuted. A quorum of half the members of the Sailing Committee shall be required to conduct business.

11. Annual General Meeting

The Annual General Meeting shall be held on or before the 7th December each year and a notice of it shall be sent to each member of the Club at the address of each member recorded in the register of the members. A quorum of 20 members is required. At any Annual General Meeting or Extraordinary General Meeting each partner shall be entitled to one vote for such partner's Family membership and each Single member, Senior member or Young Adult member shall be entitled to one vote, but Cadet members, Outport members and Family members, save as above, have no votes but can submit recommendations.

12. Extraordinary General Meeting

An Extraordinary General Meeting may be called at the request in writing of ten full members of the Club and the business of such meetings shall be restricted to the particular business mentioned in such request and a quorum of twenty members is again required.

13. Admission of Members

New members must be proposed and seconded by Club Members in writing on application forms obtainable from the Secretary. They shall demonstrate in their application to the Executive Committee's satisfaction that they intend to become active members of the club and intend to utilise the Club's facilities in keeping with the "Objects of the Club" as noted herein Rule 2. The names and addresses of persons proposed as members other than Honorary and Temporary members of the Club shall be displayed in a conspicuous place in the Club premises for at least one week before their election, and an interval of not less than two weeks shall elapse between the nomination and election of such members. Unless proposed or seconded by a member of the Executive Committee, the applicant shall be interviewed by at least one member of this Committee, before the application is considered by the Executive Committee, when a ballot shall be taken on the admission of the proposed new member at which a majority vote shall decide the question of admission.

14. Non Compliance with Rule 13

If persons, other than temporary members, are elected as members by a procedure which does not comply with that part of Rule 13 concerning the display of their names and addresses in a conspicuous place in the Club premises for a period of at least one week before their election, they shall not be admitted to any of the privileges of membership until the expiration of a period of at least two days from their election.

15. Classes of Membership and Subscription

Classes of Membership and Subscription shall be as set out in the 1st Schedule hereto.

16. Membership Cards

All members shall carry membership cards while on the premises of the Club.

17. List of Names and Addresses of Members

An alphabetical list of the names and addresses of every official and member of the Club shall be kept on the premises of the Club.

18. Guests of Members

A guest of a member shall not be admitted to the Club premises except in the company of a member and the member shall, immediately on the admission of their guest to the Club premises, enter their name and address and the name and address of their guest in a book which shall be kept for that purpose and which shall show the date of each visit.

19. Guests of Members: Limitation on Admission

The same person, except where that person is a parent, partner, or child of a member, shall not be admitted as a guest of a member to the Club premises on more than 10 days in any period of 12 months.

20. Responsibility of Members for their Guests

A member shall be responsible for their guest strictly observing the rules and shall not leave the Club premises before their guest and a guest of a member shall not be supplied with intoxicating liquor in the Club premises unless upon the invitation and in the company of the member.

21. Purchase of Intoxicating Liquor

No person shall be paid at the expense of the Club any commission, percentage or similar payment on or with reference to purchases of intoxicating liquor by the Club.

22. Supply of Intoxicating Liquor

No person shall, directly or indirectly, derive any pecuniary benefit from the supply of intoxicating liquor by or on behalf of the Club or members or guests, apart from any benefit accruing to the Club as a whole.

23. Display of Bar Hours

A statement, printed in plain type, of the hours during which intoxicating liquor may be supplied on the premises of the Club shall be exhibited in a conspicuous part of the Club premises.

24. Supply of Intoxicating Liquor to Non-members - Off Premises

Intoxicating liquor shall not be supplied to persons who are not members of the Club for consumption outside the premises of the Club.

25. Supply of Intoxicating Liquor to Members - Off Premises

Intoxicating liquor shall not be supplied to members of the Club for consumption outside the premises of the Club except where the liquor is supplied in such quantities and during such hours, being hours within the permitted hours, and on such days as the Sub-Divisional Commander for the Police Sub-Division in which the premises are situated may authorise in writing.

26. Supply of Intoxicating Liquor to Minors

Intoxicating liquor shall not be supplied to any person under the age of 18 years.

27. Bar Hours

Intoxicating liquor may be supplied on the premises of the Club only during the hours set out in the 3rd Schedule.

28. Annual Subscriptions

Membership for any year starts on 1st January. Subscriptions shall be due and payable on 1st January in each year in accordance with the rates as set out in Schedule 1. Members joining after 1st August in any year are liable for half subscription. Members joining after 1st October in any year pay no subscription for that year.

29. Entrance Fee

Each applicant on admission to Family, Single and Cadet Membership shall be required to pay an Entrance Fee in accordance with the rates as set out in Schedule 1.

30. Unpaid Subscriptions

Until his or her subscription for the current season shall have been paid, a member shall not be entitled to take part in any Club event or make any use of the Club facilities nor shall points be awarded to any boat in which he/she sails. A list of members whose subscriptions are still unpaid at 30th June shall be submitted to the Executive Committee by the Honorary Treasurer, as soon as possible after that date and the Executive Committee shall have power thereafter, and after such notice as the Executive Committee shall deem reasonable, to remove the name of any member whose subscription is unpaid from the list of members and such person shall forfeit all rights to or claims upon the Club's assets.

31. Resignations

These should be in writing and made before the Annual General Meeting for that year otherwise the member shall be deemed liable for his subscription for such year.

32. Complaints, disciplinary, hearings, sanctions, and appeals.

To be dealt with by the Executive Committee, any complaint shall be in writing and delivered to the Hon Secretary. The Hon Secretary shall inform the Executive Committee, and refer the matter to an Investigation Team of people removed from the complaint. The team will carry out an investigation to include talking to the parties involved. The findings will be presented in writing to the Executive Committee who will decide by ballot whether or not there is a case to answer. If there is, the Executive Committee shall refer the matter to a Disciplinary Committee convened to hear the matter. Those on the Disciplinary Committee shall not have been involved in the investigation or the decision on whether there is a case to answer.

32. Continued...

The Disciplinary Committee shall hear the case. Protection will be provided to witnesses who whistle blow during investigation or hearings. The Executive Committee should put any charges to individuals concerned, stating the rule which the member's behaviour has allegedly breached. The Executive Committee shall have the power to expel a member or suspend a member from the privileges of membership for a period not exceeding one month. Members suspended or expelled shall forfeit all rights to or claims upon the Club or its funds. Sanctions, other than suspension & expulsion are possible, including suspension of certain membership rights, suspension of duties or office, or deduction of racing points. Appeals shall be in writing and delivered to the Hon Secretary, stating the grounds of appeal, and made within 14 days of the member being informed of the outcome of a hearing. Appeals shall be referred by the Secretary to the Executive Committee, or if necessary, to a body beyond the club. The club shall refer to its Code of Conduct to determine the standards of behaviour expected of members. Any related matter not fully detailed in this rule shall be dealt with in general accordance with the principles in the Labour Relations Agency (LRA) Code of Practice on Disciplinary and Grievance Procedures (NI) guide, or equivalent NI guidance document.

33. Changes in Rules

No rule of the Club shall be changed or added to or revoked except by a special resolution of not less than two thirds of the members present and voting at the General Meeting or a Special General Meeting of which resolution seven days' previous notice in writing shall be given to each member.

34. Proposal of Resolution by Members

If any member shall desire to propose any resolution for the amendment of the Club Rules he shall give notice in writing of such proposal to the Honorary Secretary by 31st October in any year.

35. Trustees

At least four Trustees shall be appointed by the Executive Committee to hold office, until death or resignation or removal from office by a resolution of the Executive Committee, and, in such circumstances, the Executive Committee shall appoint a successor whose appointment shall be ratified by the Annual General Meeting. The Trustees shall have power to acquire, hold, mortgage, charge and dispose of and shall have vested in themselves all real and personal property, lands, buildings, hereditaments and premises purchased, taken on Lease or otherwise acquired by or for the benefit of the Club.

36. Club Assets

The Club's assets and finances shall be used solely to further the objects of the Club. At no time or under no circumstances shall assets of the Club be distributed among members either on an interim or on a winding-up basis.

37. Dissolution

A resolution to dissolve the Club shall be passed only at a General Meeting specially summoned for the purpose of such resolution if supported by not less than 50% of those present and entitled to vote. In the event of the Club being dissolved, surplus assets remaining after the satisfaction of debits and liabilities shall be held in trust by the Trustees until transferred by them to an institution or an organisation, which is a charity and/ or is a registered Community Amateur Sports Club (CASC) and with objects similar to those of East Down Yacht Club, provided that such an institution's or such an organisation's Rules similarly preclude the distribution of such assets to its members.

38. Non Voting Members

Persons shall not be admitted in such numbers to membership not carrying rights of voting in relation to the affairs of the Club as will result in the number of members not having such rights being more than the number of members having such rights.

39. Admission of Honorary and Temporary Members

No persons shall be allowed to become Honorary or Temporary members of the Club or be relieved of the payment of the regular entrance fee or subscription, except those possessing the following qualifications:

Honorary Members - Elected by the Executive Committee. These being existing or recent past members of the Club to be honoured in recognition of meritorious work for the Club or for special achievement in the sport of sailing.

Temporary Members - Those participating in training or sailing events approved by the Executive Committee.

40. Financial Year

The financial year of the Club shall end on 30th September in each year.

41. Moorings

Members will comply with the general directions of the Executive Committee as to the position and type of any mooring laid in the vicinity of the Club. The Committee will identify a source of professional guidance to advise on the weight, length and strength of moorings. The Moorings Officer, appointed by the Sailing Committee, will aid free navigation in the vicinity of the Club by advising on the position of moorings. All moorings for members' boats shall be inspected and serviced annually, to preserve the reputation of East Down Yacht Club as a safe location for mooring yachts. Boat owners are responsible for the good condition of both their boat and their mooring and shall be guided by the insurance requirement of Rule 42.

42. Navigation, Racing and Sailing

All racing is to be conducted under the rules of the Royal Yachting Association and every helmsman is to be a member of a recognised club.

All craft taking part in Club activities or using Club facilities must be insured against Third Party Liability to a minimum of £3,000,000.00.

No boat belonging to a Club member may be awarded points in a Club event unless its particulars have been reported previously to the responsible Officer of the Club, in such a manner as the Executive Committee may prescribe, and unless it carries clear identifying sail numbers and/or name in accordance with the reported particulars, and unless all dues to the Club in respect of the boat have been paid, and unless the helmsman and crew are fully paid members of the Club or bona-fide visitors, subject to the further restriction that any such visitor may not participate in more than five Points Series races in any one season.

Personal buoyancy aids must be worn at all times by persons in dinghies and tenders. A 5 knot speed limit (speed over the ground) is imposed in the immediate area of the clubhouse waters bounded to the North by Dodd's Island and in the South by the entrance to the Dorn (often marked by perches), during the sailing season.

The following list of vessels has permission to exceed the speed limit:-

Club support vessels, club safety boats and club rescue boats in their immediate race management and safety/rescue duties only, not on general passage making, subject only to safe and considerate helming.

43. Classes of Sailing Boats

The official classes of boats sponsored by the Club shall be determined or amended at the Annual or Special General Meeting. Other boats will be eligible to participate in handicap races under the RYA Portsmouth Yardstick Scheme or other such recognised handicap scheme as the Executive Committee may decide.

44. Instruction in Seamanship

In order to comply with the objects of the Club, membership of it entails the provision of boats and qualified instructors and the Executive Committee will make adequate arrangements for the instruction of new, young and inexperienced members and their families during the sailing season, and shall arrange winter sessions on such subjects as seamanship, safety at sea, racing rules, boat maintenance and boat building.

45. Colours and Badges

The colours of the Club shall be maroon and white and the burgee of the Club shall be a Viking Longship, white on a maroon field.

46. Caravans

The use of caravans on the Club property shall be regulated in accordance with the Caravan Section Rules in the 2nd Schedule hereto.

47. Boat Park

Any keelboat or trailer remaining in the Boat Park or in the Dinghy Park must be moved, before 31st May, to such area as is designated by the Executive Committee. Any boat or trailer remaining after that date will be moved and the expense reclaimed from the owner.

Subject to the discretion of the Executive Committee, a charge may be made as specified in Schedule for any keelboat or other boat remaining in the Boat or Dinghy Park between 1st June and 31st August. Every boat, dinghy, punt, cradle and trolley remaining on EDYC property shall carry clearly visible identification.

48. Parking

The allocation of parking space to any boat or trailer/cradle, or caravan on any part of the Club site shall be at the discretion of the Executive Committee. All members wishing to park such equipment on the site must apply to the Executive Committee.

49.

(a) Equipment/Property Identification

The club instructs that every boat, tender, trailer, trolley, caravan or piece of equipment at EDYC (above the size of and including optimist dinghy) shall be marked legibly with an identification name and that this identification name be recorded on the member's annual membership renewal census form or given to the secretary before the equipment's entry to EDYC property. The identification name may include the boat class and sail number e.g. W6657 & T44956. Equipment without identification so registered will be treated under rule 49b

(b) Abandoned Property

Any property on the Club site which has no visible identification or whose owner cannot, after reasonable enquiry, be identified, shall be disposed of at the discretion of the Executive Committee.

(c) Power to remove, sell or dispose of boats and/or trailers

In the case of an abandoned or unauthorised boat and/or trailer and/or equipment (as defined below) the Executive Committee may:-

- 1. move the boat and/or trailer and/or equipment to any part of the club premises without being liable for any loss or damage to the boat and/or trailer howsoever caused;
- 2. upon giving 1 months' notice require the member or former member to collect the boat and/or trailer and/or equipment;
- upon giving three months' notice in writing by registered post to the member or former member at his/her last known address shown in the register of members sell the boat and/or trailer and/ or equipment and deduct any monies due to the Club (whether arrears of subscription or facility fees or boat park fees or otherwise);

- 4. if the boat and/or trailer and/or equipment is unsaleable (in the reasonable opinion of the Committee), after giving notice in writing as aforesaid, dispose of the boat and/or trailer and/or equipment in any manner the Committee may think fit and deem the cost of doing and any arrears as aforesaid to be a debt owing to the club by the member or former member.
- 5. the club reserves the right to charge storage for the boat and/or trailer and/or equipment until such time as the owner collects the boat and/or trailer and/or equipment or until notice has been served under clause (2) and (3) above.

Provided that in each case that proper evidence is available to show that all reasonable steps have been taken by the Executive Committee to trace a member or former member and that when and if the boat and/or trailer and/or equipment is sold the proceeds of sale (where these exceed the amount of any indebtedness by the member or former member to the club) shall be placed in a bank deposit account and retained against the eventuality of a claim by the owner (whether he be the said member or former member) for a period of six years.

The Executive Committee shall be entitled to treat any of the following as an abandoned or unauthorised boat and/or trailer and/or equipment :

- 6. a boat and/or trailer that remains on Club premises for more than one month after any date advised by the Committee by which boats and/or trailers must be removed to allow for maintenance works of the boat park or the end of the season date (where applicable);
- 7. a boat and/or trailer which is the property of a member or former member which remains on club premises after any fees payable to the club by any member or former member (whether by way of arrears of subscription or facilities fees, boat park fees or otherwise) are more than one month in arrears;
- 8. a boat and/or trailer which is the property of a member or former member which overstays by more than a month following the termination of the storage agreement;
- 9. a boat and/or trailer which is the property of a former member which overstays by more than a month following the termination of their membership.

(d) Lien on boats and/or trailers and/or equipment.

In addition to the powers set out above to move, sell or dispose of boats and/or trailers and/or equipment the Club shall have a lien over members' or former members' boats and/or trailers and/ or equipment parked or stored on the club's premises in respect of all monies due to the Cub, whether in respect of arrears of facilities fees or subscriptions or otherwise and shall be entitled to retain possession of the boat and/or trailer and/or equipment until such time as all monies due to the club have been paid in full.

50. Safety of Equipment

All caravans and trailers on the Club site must be maintained in good running order and must be fit for the intended purpose. If necessary, a contractor should, with the authority of the Executive Committee, be able to move any equipment on the site without endangering either himself or the property to be moved.

51. Dogs on Site

Any dog within the grounds of East Down Yacht Club should be kept under supervision and controlled at all times and any fouling that occurs should be removed by person responsible for the dog at the time.

52. Deed of Trust

No provision in these Rules or in any amendment thereto shall operate, detract from or qualify the terms of the Trust of the Club property.

The Honorary Treasurer may, at the discretion of the Executive Committee, provide a scheme for payment of Annual Subscriptions and associated charges by instalment. An administration fee will be charged for this service. Details of the scheme in operation for any year will be provided with the request for Annual Subscription.

Members whose instalment payments are in order shall be deemed to be fully paid members of the Club for the purposes of Rule 30 (Unpaid Subscriptions).

Penalties

A late payment surcharge of 10% of the full annual rate shall be applied to all subscriptions outstanding after 31st March with the following exceptions :-

- Those members who have advised the Membership Secretary in writing that they have opted to pay their subscriptions in 6 or fewer staged payments and who have transferred the first payment to the Club account by 31 March.

- Any individual case which the Executive Committee considers to be extenuating circumstances where an application has been made in writing to the Executive Committee by the last day in February.

SCHEDULE 2 : CARAVAN SECTION

Rules for the regulation of caravans on the site adjoining the Club House of the East Down Yacht Club.

The Executive Committee of the East Down Yacht Club has full authority to administer these rules. All payments made by members of the Caravan Section shall become part of the finances of the Yacht Club and shall be under the absolute control of the Treasurer and Committee of the Yacht Club.

The Executive Committee of the East Down Yacht Club shall have power to discipline members of the Caravan Section according to these rules or according to the rules of the Yacht Club.

Members of the Caravan Section shall pay an annual donation, as detailed in the 1st Schedule, for a right to occupy a site on the caravan park. New members to the Caravan Section shall make a

one off, non-refundable donation as detailed in the 1st Schedule. Outside the sailing season caravans shall be stored at locations identified as suitable by the Executive Committee. An annual winter storage charge equivalent to a Keelboat below 20ft shall be paid.

All caravans on Club property must be insured against Third Party Liability to a minimum of £1,000,000.

The Executive Committee shall have power, after request, to have a caravan removed from the site at any time during the year, apportioning the subscription accordingly.

Membership of the Caravan Section shall be confined to those paying a Family subscription and who are boat owners.

The membership of the Caravan Section shall be limited to 45 families and when this number is reached the membership shall be closed.

Application for membership shall be made to the Executive Committee of the Yacht Club who shall deal with applications in strict rotation.

The Executive Committee of the Yacht Club shall have full authority to accept or refuse application for or terminate membership of the Caravan Section, and have full authority to amend or terminate existing allocation of sites.

Members proposing to remove their caravan from the site for a period of one week or longer shall give at least one week's prior notice of removal to the Secretary of the Yacht Club or his nominee who shall have power to grant temporary membership of the Caravan Section to any member on payment of a donation to be determined by the Executive Committee.

The Executive Committee of the Yacht Club shall each year nominate three members of the Caravan Section who shall have full power to allocate sites to existing members, to organise voluntary labour to improve the amenities of the caravan park and to report to the Executive Committee of the Yacht Club any serious breaches of the rules of the Caravan Section. The Executive Committee shall allocate every caravan a site number. Every caravan, whilst on EDYC property, shall permanently display its site number in the window nearest the draw bar.

All caravans in the Boat Park or Dinghy Park must be moved, prior to Opening Day, to their designated sites. Any caravan remaining in the Boat Park or Dinghy Park after that date will be moved to its designated site and any expenses incurred will be reclaimed from the owners.

SCHEDULE 3 : BAR HOURS

The hours of opening of the Club Bar shall be within 11.30 am to 11.00 pm on any social or sailing occasion for which the Executive Committee may agree that Bar facilities should be provided. Also, the Bar may be open from 6:00 pm to 11.00 pm on each Wednesday during the Sailing Season, and from 11.30 am to 11:00 pm on each Saturday during the Sailing Season.

If such facilities are provided on a Sunday (or a Christmas Day) the permitted opening hours shall be from 12.30 pm to 7.30 pm.

If such facilities are provided on Good Friday the permitted opening hours will be limited to the period between 5.00 pm and 11.00 pm.

APPENDIX A : CHILD PROTECTION POLICY

Those working with young people should have access to the RYA's 'Safeguarding and Child Protection Policy and Guidelines' (available to download at www.rya.org.uk)

Policy Statement

It is the policy of East Down Yacht Club to safeguard children and young people taking part in Club activities from physical, sexual or emotional harm. The Club will take all reasonable steps to ensure that, through appropriate procedures and training, children participating in Club activities do so in a safe environment. We recognise that the safety and welfare of the child is paramount and that all children, whatever their age, gender, disability, culture, ethnic origin, colour, religion or belief, social status or sexual identity, have a right to protection from abuse.

For the purposes of this policy anyone under the age of 18 should be considered as a child. All members of the Club should be aware of the policy.

Volunteers

All Club volunteers whose role brings them into regular contact with young people will be asked to provide references. The Child Protection Officer and those instructing, coaching or supervising young people or instructors will also be asked to apply for an Enhanced Criminal Records Disclosure.

Good Practice

All members of the Club should follow the good practice guidelines as set out below :-

- Avoid spending any significant time working with children in isolation.
- Do not take children alone in a car, however short the journey.
- Do not take children to your home as part of your organisation's activity.

Where any of these are unavoidable, ensure that they only occur with the full knowledge and consent of someone in charge of the organisation or the child's parents.

Design training programmes that are within the ability of the individual child.

If a child is having difficulty with a wetsuit or buoyancy aid, ask them to ask a friend to help if at all possible.

If you do have to help a child, make sure you are in full view of others, preferably with another adult.

You should never:

- engage in rough, physical or sexually provocative games.
- allow or engage in inappropriate touching of any form.
- allow children to use inappropriate language unchallenged, or use such language yourself when with children.
- make sexually suggestive comments to a child, even in fun
- fail to respond to an allegation made by a child; always act
- do things of a personal nature that children can do for themselves.

It may sometimes be necessary to do things of a personal nature for children, particularly if they are very young or disabled. These tasks should only be carried out with the full understanding and con- sent of the child (where possible) and their parents/carers. In an emergency situation which requires this type of help, parents should be fully informed. In such situations it is important to ensure that any adult present is sensitive to the child and undertakes personal care tasks with the utmost discretion.

Those working with young people should be aware of the guidance on recognising abuse, see Appendix A of the RYA 'Safeguarding and Child Protection Policy and Guidelines'

Adults are requested not to enter the showers and changing rooms at times when children are changing before or after junior/youth training or racing. If this is unavoidable it is advised that they are accompanied by another adult.

The Club will seek written consent from the child and their parents/carers before taking photos or video at an event or training session or publishing such images. Parents and spectators should be prepared to identify themselves if requested and state their purpose for photography/filming.

If the Club publishes images of children, no identifying information other than names will be included. Any concerns about inappropriate or intrusive photography or the inappropriate use of images should be reported to the Club Welfare Officer.

Concerns

Anyone who is concerned about a young member's welfare, either outside or within the Club, should inform the Club Welfare Officer immediately, in strict confidence. The Club Welfare Officer will follow RYA procedures.

Any member of the Club failing to comply with the Child Protection policy and any relevant Codes of Conduct may be subject to disciplinary action under Club Rule 32.

Social Media

Social Media (Facebook, What's App, YouTube, Instagram, and the Club Website etc) is a great way for EDYC to share information with their members and others who may potentially be interested in the Club.

Whilst EDYC recognises the benefits of using social media, it can be, sadly, at times misused and it is essential that members make informed decisions about how they use social media, in order to protect our club and our people.

In addition to following the rest of this Code of Conduct it is the responsibility of all members to:-

- Be respectful at all times posts/comments can be viewed by all members.
- Refrain from publishing comments that could be controversial or potentially inflammatory subjects ie politics, religion etc.
- Avoid hostile or harassing communications or comments that could be viewed as abusive, offensive or derogatory. Harassment is any offensive conduct based on a person's race, sex, gender identity, national origin, colour, disability, age, sexual orientation, marital status, religion or any other status protected by law.
- Remember that even when you are not using EDYC sites you may still be associated with the club and may by your actions give the Club or its activities a bad name.

When on East Down Yacht Club social media platforms/pages:-

- only post club related subjects i.e. sharing sailing experiences and race experiences, sharing sailing related photos, organising informal social sails, training tips, club night information, promoting club activities.
- do not use social media for advertising for commercial gain unless prior approval of the Executive has been gained.
- do not use social media to raise issues with the Executive. If an issue has arisen this needs to be sent to the Executive Committee through the EDYC Honorary Secretary.
- be aware of publishing copyrighted or borrowed material with citations and links. When publishing direct paraphrased quotes, thoughts, ideas, photos or videos, give credit to the original publisher or author.

EDYC Executive Committee and EDYC Sailing Committee reserve the right to delete any post or comment within any social media platform without warning or notice. Persistent inappropriate posting or commenting will result in being banned from the social media platform and/or club disciplinary action.

Participants - Young Sailors

- Listen to and accept what you are asked to do to improve your performance and keep you safe.
- Respect other participants, coaches, instructors, officials and volunteers.
- Abide by the rules and play fairly.
- Do your best at all times.
- Never bully others either in person, by phone, by text or online.
- Take care of all property belonging to other participants, the club or its members.

Parents

- Support your child's involvement and help them enjoy their sport.
- Help your child to recognise good performance, not just results.
- Never force your child to take part in sport.
- Never punish or belittle a child for losing or making mistakes.
- Encourage and guide your child to accept responsibility for their own conduct and performance.
- Respect and support the coach.Accept officials' judgements and recognise good performance by all participants Use established procedures where there is a genuine concern or dispute
- Inform the club or event organisers of relevant medical information
- Ensure that your child wears suitable clothing and has appropriate food and drink Provide contact details and be available when require
- Take responsibility for your child's Inform the club or event organisers of relevant medical information
- Ensure that your child wears suitable clothing and has appropriate food and drink Provide contact details and be available when required
- Take responsibility for your child's safety and conduct in and around the clubhouse and the East Down Yacht Club site.
- If on site after 10pm parents/guardians should ensure they know where their children are and what they are doing, they should ensure that the quietness and calm atmosphere of the site is maintained. If their children/young people do become noisy or disruptive, parents should address it as soon as they become aware of the situation.

Coaches, Instructors, Officials and Volunteers

- Consider the welfare and safety of participants before the development of performance.
- Encourage participants to value their performance and not just results.
- Promote fair play and never condone cheating.
- Ensure that all activities are appropriate to the age, ability and experience of those taking part.
- Build relationships based on mutual trust and respect.
- Work in an open environment.
- Avoid unnecessary physical contact with young people.
- Be an excellent role model and display consistently high standards of behaviour and appearance.
- Do not drink alcohol or smoke when working directly with young people.
- Communicate clearly with parents and participants.
- Be aware of any relevant medical information.
- Follow RYA and Club guidelines and policies.
- Holders of RYA Instructor and Coach qualifications must also comply with the RYA Code of Ethics and Conduct.
- Holders of RYA Race Official appointments must also comply with the RYA Race Officials Code of Conduct.
- If you are concerned that someone is not following the Code of Conduct, you should inform the Child Protection Officer or the person in charge of the activity or session.

APPENDIX C : Statement of Policy and Intent in relation to Health and Safety

1. East Down Yacht Club considers that one of its primary objectives is the achievement and maintenance of a high standard of health and safety on its premises, and in all activities conducted

under its jurisdiction.

2. The Club also recognises the need for, and seeks to promote, a healthy and safe working environment for all it's members, guests and employees, while they use the Club's premises and equipment.

3. The Club will take all reasonably practicable steps to fulfil its responsibility and will pay particular

attention to meeting statutory requirements and RYA guidance.

4. The Club requires members to display a positive attitude towards Health and Safety and, in addition to abiding by the Club Rules and Sailing Instructions, members should adhere to safety procedures and instructions which have been endorsed by the Executive Committee.

Club Series Races 2024 SAILING INSTRUCTIONS

1. RULES

- 1.1. The event is governed by the rules as defined in The Racing Rules of Sailing (2021-2024).
- 1.2. The prescriptions of the Royal Yachting Association (RYA) shall apply.
- 1.3 Racing rules 25, 26, 29.2,35, 40, 61.3, 62.2, 63.1, A4

2. NOTICES TO COMPETITORS.

2.1 Notices to competitors will be posted on the EDYC website and optionally on the results notice board in East Down Yacht Club.

3. CHANGES TO SAILING INSTRUCTIONS.

3.1. Any change to the sailing instructions will be posted before 18.00 on the EDYC website or the results notice board 24hrs before it will take effect, except that any change to the schedule of races will be posted by 12.00 on the day before it will take effect.

4. SIGNALS MADE ASHORE.

4.1 Signals made ashore will be displayed at the main flagpole at East Down Yacht Club (EDYC) but may not be accompanied by a sound signal.

5. SCHEDULE, CLASSES.

- 5.1. The dates of club series races are scheduled as per the club sailing calendar published on the website: www.edyc.co.uk & in the club handbook. Races between 27th April 2024 to 14th Sept 2024 in Early Saturday Series (ES), Early Wednesday Series (EW), Late Wednesday Series (LW) and Late Saturday Series (LS).
- 5.2. Classes and Times of Warning Signal:

YTC 1 (YTC base number: 1000 and under) Impala (One Design Class)	14:23	19:17	18:44
YTC 2 - (YTC base number: 1001 and over) YTC RS	14:26	19:20	18:47

- 5.3. Times shall be taken from the visual signals; the absence of a sound signal shall be disregarded.
- 5.4. On Saturdays any class may have two races if the Race Officer accommodates. The second race will start as soon as practicable after the finish of Race 1, however the Race 2 warning signal for a class will be no later than 15:45. The Race Officer may sweep the course, giving an order and time of finish to remaining boats, to enable a second race. There will be no handicap adjustment for swept boats.
- 5.5. Wayfarers, GP14s & Lasers shall compete on handicap in the appropriate Dinghy class and shall also be scored as separate classes on a level basis against other boats of the same one-design class for separate awards.
- 5.6. A dinghy with PY handicap in the range 1141 and over may elect to race for the entirety of the season in the Dinghy class other than that defined in SI 5.1, provided that a written declaration to this effect has been lodged with the Sailing Captain more than 3 days before their first race.

In the absence of any such declaration, a boat shall start in the appropriate class and shall be scored in the handicap race and series corresponding to its YTC or PY number as issued, or as competed in the previous year. A boat shall remain in the appropriate class according to the handicap and class allocated at the beginning of the season, with no option to change at any time, unless a race committee decides that the performance of a particular yacht is inequitable.

6. CLASS FLAGS.

6.1. Class flags shall be the following Code Flags:

7. COURSES & MARKS.

- 7.1.Courses will be set from a committee boat moored within Holm Bay & using marks laid around Strangford Lough, identified via a chartlet in Appendix A.
- 7.2. Courses are designated by letters and are specified in a List of Courses, published in the Club Handbook and can also be downloaded from <u>www.edyc.co.uk</u>.
- 7.3.There will normally be a committee vessel start with a laid line utilising a mark E as the line end mark.
- 7.4. The courses to be sailed by the classes shall be indicated by course letters being displayed in the following positions on the Committee signalling vessel.

Class	Position
YTC1/Impala	Port Side, forward.
YTC2/YTCRS	Port Side, Aft.
Dinghy 1	Starboard Side, Forward
Leisure 17	Starboard Side, Aft
Dinghy 2	Starboard Side, Cabin

- 7.5. The number of rounds to be sailed will be displayed with the course to be sailed for each class.
- 7.6. At the end of each round all boats must sail through the start line in the same direction that they started. Boats that do not sail through the start line on each round of the course shall be recorded as 'DNF' without a hearing. This changes RRS 63.1.
- 7.7. All boats shall pass North of Marks K and R, and to the seaward side of marks 2 and 6 unless these are marks of the course.

8. THE START.

- 8.1. RRS 26 shall not apply and signals will be made at three minute intervals.
- 8.2. This paragraph refers to the Saturday times (para 5.1), however the other times eg Wednesday times can be substituted appropriately from para 5.1.
- 8.3. The Race Officer will commence with seven flags raised on halyards, flying and visible on the halyards well before 14:17 on Saturdays & 19.17, no sound signals will have been made.
- 8.4. The prep signal for each succeeding class will be the starting signal of the preceding class. Except in the case of YTC1/Impala where the prep signal is the lowering of the green & white chequered flag.
- At 14:17/19.17 The **red & white chequered flag** will be removed auto hoot started. This starts the squence for **all classes**.
- At 14:20/19.20 The green & white chequered flag will be lowered the prep signal for YTC1/ Impala.
- At 14:23/19.23 The H flag & No.7 Flag will be lowered for the start signal for YTC1 / Impala.
 Also this is the prep signal for YTC2 / YTC RS
- At 14:26 The **G flag / No.4 Flag** will be lowered for the start signal for **YTC2 / YTC RS** Also this is the prep signal for **Dinghy 1**.
- At 14:29 The **W flag** will be lowered for the start signal for **Dinghy 1**. Also this is the prep signal for **Leisure 17**.
- At 14:32 The **B flag** will be lowered for the start signal for **Leisure 17**. Also this is the prep signal for **Dinghy 2**.

• At 14:35 - The **T flag** will be lowered for the start signal for **Dinghy 2**. All flags are on deck and auto hoot is turned off.

- 8.5. The starting line will be between the rear mast on the committee vessel and a Mark E.
- 8.6. The starting signal for each class shall be the lowering of the class flag for that class as above.
- 8.7. In the case of a general recall that class will start 3 minutes after the Dinghy 2 start. In the case of two or more general recalls, starts will be in the standard sequence of starts at 3 minute intervals.
- 8.8. A boat starting later than 6 minutes after her starting signal will be scored 'Did Not Start (DNS). This changes rule A4.
- 8.9. Boats whose warning signal have not been displayed shall keep clear of the starting area.

9. THE FINISH.

- 9.1 The finishing line will be between the rear mast on the committee vessel and a Mark E.
- 9.2 Course changed to shortened course: Shortened courses are listed alongside full course codes in the List of Courses described in 7.2. When a class is required to change course and to sail a shortened course, the Committee Vessel shall display Code Flag C above the class flag of any class affected, before the leading boat in that class crosses the start/finish line at the end of a round. Code Flag C shall be displayed alone if all classes are required to change to sail a shortened course. Code Flag C displayed at the Committee Vessel means: 'After passing the change course flag, sail on the changed course, as specified in the List of Courses.
- 9.3 An S Code Flag means: When displayed at the Committee Vessel: Finish the race at the finishing line. When displayed on a launch or other craft: Finish the race by crossing a finishing line between the craft on which this Flag is displayed and the nearby mark of the course, from the course side. If the S code Flag is displayed alone, all classes shall finish, but if flown above class flags then only the designated classes shall finish.
- 9.4 In amendment of RRS 25 and Race Signals no sound signal will be made when displaying a finishing signal.
- 9.5 The Race Officer may supplement flag signals with other means for ensuring that competitors are fully aware of his intentions regarding the changing of courses. Such means may be, for example, use of a VHF radio on Channel 37 (alternatively Channel M), a loud hailer, or a safety craft, for delivering verbal instructions.

10. TIME LIMIT.

10.1. The time limits for the various classes are as follows:

Class and Series	Time Limit
Saturday Points Series &Autumn Series. Saturdays for YTC1, Impala YTC2, YTCRS, Leisure 17 and Dinghy 1 &2 if one race only.	16.30
Saturday Points Series & Autumn Series Saturdays for Dinghy 1 & 2.	Race 1 - 16.30 Race 2 - 17.30
Wednesday Points Series races in May, June and July.	21.30
Wednesday Points Series races in August.	21.00
Autumn Series Wednesdays.	20.30

- 10.2. The RRS 2021-2024 Rule 35 shall be amended to read, all boats that finish within the time limit shall be scored according to their finishing places.
- 10.3. Unless the race is abandoned, a boat that started but did not finish shall be scored as the number of boats that started plus one.

11. PENALTY SYSTEM.

11.1. The exoneration penalty and the advisory hearing and RYA arbitration of the RYA Rules Disputes Procedures will be available.

12. PROTESTS AND REQUESTS FOR REDRESS.

12.1 Protest forms are available at the clubhouse at EDYC. Protests shall be delivered there to an Officer of the club, within the protest time limit which is 60 minutes after the last boat has finished the last race of the day. The same time limit applies to protests by the race committee and protest committee about incidents they observe in the racing area and to requests for redress. This changes rules 61.3 and 62.2.

13. SCORING AND AWARDS.

13.1 The number of races to count in a Series shall be fewer than the number of races sailed in accordance with the following scale, and shall be subject to the restriction that points awarded for a disqualification for unfair sailing shall not be discarded:

Number of races sailed	Number of discards
10, or more	3, or more to be communicated
7-9	2
5-6	1
4 or less	0 (all to count)

13.2. Awards & Prizes, will be given as follows:

Overall Series Class Championship.

Awarded in each class, to the boat with the least points based on its best scores from 12 race starts, including a maximum of 2 compensation points scores in all Series. Overall best performing Impala.

Individual Series. Awarded in each Series, in each class, to the boat with the least points from a minimum of 3 race starts and scored as above.

GP14/Wayfarer Overall Winner. Awarded to the best GP14 based on the same criterion as the Overall Series Class Championship.

13.3. Compensation Points for duties.

Any boat claiming compensation points as described in this notice shall ensure that the claim is recorded on the Race Officer's race results sheet for that date and by a named entry in the club service boat log book (on the correct date page) in the RIB shed.

Provided that an appropriate declaration is made, a boat which is unable to race because its crew is carrying out race or house duties will, on conclusion of the series, be awarded compensation points for the race/s concerned.

These shall be calculated as the average of her scores in the races of the series, apart from the race/s concerned and apart from any other race/s, not exceeding the number of race scores in the series which may be discarded.

- 13.4. An emergency stand in duty can happen when a person scheduled for a duty does not show up. If there is any doubt the Race Officer (or Acting Race Officer) shall decide if the duty was an emergency stand in and shall endorse the results sheet appropriately. An emergency stand-in Race Officer will get compensation points equal to that of first place.
- 13.5. Compensation points for emergency stand-in RIB helm and crew or Chevvy driver get compensation points equal to their best score from any race in the current series.
- 13.6. Races with at least one starter, shall be scored. A race with no starters is not a race however compensation points may still be claimed.

Sailing Instructions East Down Yacht Club

13.7. A boat may make one claim per series for average Compensation points (as per above) when competing in one Strangford Lough Open event per series that would otherwise prevent a start in the

EDYC Series race. Claims for these points must be made to Rear Commodore Sailing or the Sailing Captain within one week of the Strangford Lough Open event and must be accompanied by evidence to the satisfaction that the boat started the other event.

14. HANDICAPPING SYSTEMS.

- 14.1 Races are under the YTC or PY Handicap systems as indicated in the schedule.
- 14.2 Application of the RYA YTC Handicap Systems Boats racing under the YTC will use an RYA YTC handicap number as calculated by: https://rorcrating.com/ryaytc/
- 14.3. The established classes shall have a handicap number at the start of their 2024 series assigned from the RYA YTC RORC Rating Office or Portsmouth Number List 2024
- 14.4 Boats racing under the PYS will have their handicaps determined by the Sailing Committee in accordance with the current published RYA PYS list and remain at that figure for the year, unless changed by the RYA. PYS Trial Numbers issued to boats with no, or an inequitable PYS handicap will be assessed and liable to change after each assessable race until judged to be stable and a Club Number issued by the Sailing Committee.

15. SAFETY.

- 15.1 All Dinghy 1 and Dinghy 2 class boats must fulfil class rules concerning buoyancy, means for bailing, towropes and means of manual propulsion (paddles).
- 15.2. RRS 40 is amended to read: All dinghy classes must wear an adequate personal flotation device while racing. Wetsuits and drysuits are not personal flotation devices.
- 15.3 All keelboats must carry the following safety equipment while racing: Engine (in-board or outboard), fuel for 1 hour motoring, sail number on mainsail, fire extinguisher, bucket and lanyard, warp (2 x LOA of boat), torch, adequate anchor and warp, foghorn, personal floatation devices for all crew members and First Aid equipment.
- 15.4 Boats **must** accept help if so directed by a safety crew. Non-acceptance of such help shall result in disqualification.
- 15.5. In amendment of RRS 1.2 & 40, all sailors shall wear adequate personal buoyancy at all times when afloat in club vessels.

16. SAIL NUMBERS.

- 16.1 Boats shall display a clearly visible sail number on their mainsails.
- 16.2 A boat may temporarily use a mainsail carrying a different number from her allotted number provided notice of this intention is given to the Race Committee for each individual race of the series before going afloat. Recording a sail number as for example "16081 using number 702" on the signing out sheet referred to in information below is acceptable written notice for the purpose of this SI, as is verbally informing the RO on the committee boat.

17. RADIO COMMUNICATION.

17.1 A boat that is racing can make voice or data transmissions. Such voice or data communications shall be made available to all boats where practical. The use of channel M1/37 is available to assist competitors, race management and safety.

18. PRIZES AND AWARDS.

18.1 A prize will be awarded to each winner in the classes. This prize may be included with any overall series awards as indicated in section 13 Scoring and awards.

19. RISK STATEMENT.

Sailing by its nature is an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

 a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;

b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;

- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities.

f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions as can be practically provided in the circumstances.

20. INSURANCE.

20.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3.000.000 per event or the equivalent.

21. INFORMATION.

- 21.1. The Race Officer may cancel or abandon races if, in their opinion, available safety facilities are inadequate. This may involve the use of the N flag.
- 21.2. Mast head buoyancy is recommended for dinghies where inversion presents a recovery challenge.
- 21.3. The Race Officer may move mark E after the start to ensure the finish line is clearly open from the last mark of the course. After finishing boats are requested to keep clear of the Finishing Line and the sight lines from the Committee Vessel to those boats approaching the finish line.
- 21.4. Protest forms and RYA arbitration Competitors are advised to make use of the RYA Protest Form, which is available along with information on the RYA arbitration procedure on the EDYC Club Notice Board and in the entrance hall of the Clubhouse.
- 21.5. A signing out and in sheet will be provided, located in the green shed attached to the notice board for helms and crews in the Dinghy classes. This sheet will be collected with the results sheets and is to enable the Race Officer to ensure that all boats and crews which used the slipway and raced are accounted for. All Dinghy competitors are requested to complete this for safety reasons. It will also improve accuracy of recording entries/results including sail numbers and size detail, especially in relation to Lasers and Toppers and their sail sizes.
- 21.6. All RIB and Chevy crews are required to put an entry in the Sailing Office log book for the vessel used, especially reporting any equipment related notes.
- 21.7. The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions as can be practically provided in the circumstances.



Rules for the Pontoon and the Dorn

PONTOON FACILITIES

Wind Conditions

Members and Visitors are welcome to use the pontoon except in strong and gale force winds, and always under the direction of the Sailing Committee.

Personal Buoyancy

A Personal Flotation Device must be worn by children under 12 years of age and by all non-swimmers using the pontoon or the approach Walkway and Bridge.

Club Reserved Spaces

The positioning of club boats takes precedence over member's boats. Space for the Chevvy and for a RIB to be left in the water must be maintained. The north side of the pontoon is reserved for the Chevvy.

Rafting and tying up

Yachts may be tied up providing the skipper or owner remains on-site. Rafting, in suitable conditions, to a maximum of three boats is permitted with lines to the pontoon from the outside boats. Those in highly manoeuvrable boats should consider leaving as much of the pontoon length as clear as possible for larger less manoeuvrable boats.

Clearing the Pontoon

Space may be required to be cleared or reserved for Training, Safety, Event Management or an Emergency.

Prolonged Use

In the event of breakdown, dispensation may be given by the Executive Committee for the use of the pontoon provided the boat is being worked on actively.

Environment

Skippers are required to adhere to good environmental practice at all times, especially while moored to the pontoon. This includes not discharging of waste to the environment and the transport of refuse to bins on shore. Unattended obstructions or tripping hazards on the pontoon must be avoided.

THE DORN

Visitors Moorings

The Moorings (two grey buoys to the east of the Club pontoon) referred to as Visitors Moorings are maintained by EDYC at the club expense, they assist to promote sailing in Strangford Lough. They are for the use of visitors and are not for the routine or extended use of members. Please do not abuse this facility. Members should vacate these moorings as soon as possible, giving visitors and other members access and use.

Speed & Wash

A 5 knot speed limit (speed over the ground) is imposed in the immediate area of the clubhouse waters bounded to the North by Dodd's Island and in the South by the entrance to the Dorn (often marked by perches), during the sailing season.

The following list of vessels has permission to exceed the speed limit :-

Club support vessels, club safety boats and club rescue boats in their immediate race management and safety/rescue duties only, not on general passage making, subject only to safe and considerate helming.

HEALTH AND SAFETY

EDYC has adopted a Health & Safety Policy (see Handbook Appendix C), to which the following notes will assist members.

H&S Training & Guidance

The Executive will provide both training and guidance on any aspect of club activity, on request, with a view to making our activities safe. A wide range of activity has an associated risk and via training and guidance we aim to reduce the risk. It should be your judgement as to when your experience, training and guidance sufficiently overcome the risk. Guidance sheets are prepared in relation to crane use, winch use and other activities.

Accident Book & Reporting

The statutory accident book is retained in the kitchen. It is to be used when appropriate. The Executive need to hear of all accidents, even minor, via verbal, written and/or email reports. Monitoring and recording all incidents will give us direction on where our safety can be improved. An email or a signed note, dated and placed in the letterbox in the club entrance hall, would be simple ways to alert the Executive of a less serious accident.

Safety Maintenance

Maintenance is a continuous task and in many cases relates directly to safety. In the same way as the Executive wish to hear of accidents, they also wish to hear of maintenance tasks which, if conducted, will improve safety. Due to the importance of safety equipment, we must hear when such equipment is missing, damaged or faulty.

First Aid

The Club maintains first aid consumables in three locations - on shore in the First Aid Box in the kitchen, in the shed and afloat in waterproof containers (white barrels, red lids) on club Safety Craft. Serious incidents afloat may require Coast Guard communications and Ambulance attendance. It is recommended that each member and boat should have some first aid provision. Trained First Aiders are available in the Club and the holding of an RYA Instructor's qualification also indicates training in First Aid. A list of trained First Aiders is located with the First Aid box in the kitchen.

Assembly Point

The location of the assembly point is at the children's playpark

Vehicle parking

There are designated areas around the club site where vehicle parking is considered to be hazardous or where parking may infringe upon a right of way for others. These areas are clearly marked out in yellow paint and members are asked to keep these spaces clear for the safety and convenience of others.

Yard Crane

Do not use the crane unless you are confident of operating it safely while undertaking your task.

There are several key points to consider

- Assistance from someone else is essential
- Mast operations require three to four people as a minimum
- At least one person should be delegated the task of ensuring that other persons do not stray into the crane operating area.
- Check that the weather conditions are suitable.

TRACTOR DRIVERS

For safety reasons the tractor can only be driven by club members who have completed and passed the recognised training course. Below is a list of tractor drivers who are permitted to use the club tractor:

Strangford Lough Impala 28 Class Association (SLICA) -March 2024



It is my privilege, as SLICA Class Captain, to have my hand on the SLICAhelm for the duration of the 2024 season. I am happy to take the opportunity presented by this informal EDYC Handbook article to look back at the Impala itself as a racing yacht, its long-established presence in the EDYC racingcruiser fleet, the recent dramatic increase in our fleet numbers and what we SLICA's members see as the next steps in maintaining and further developing the fleet.

What people say about the Impala

- "The concept of the boat is as superb as it is simple"
- "It must be the fastest 28ft cruiser/racer around and is viceless into the bargain"
- "It was designed from scratch as a One-Design and that, combined with its high-quality glasswork and good design, make it well worth buying"
- "It should go without saying that such a popular boat is a joy to sail, and she is"
- "The Impala impresses with her compatibility for both cruising and racing roles"
- "For seagoing, the layout is right"
- "The OD concept of the Hunter Impala makes her an excellent all-rounder"
- "As a result of a healthy One-Design fleet she will not be obsolete in a couple of years' time, making her resale value assured"





The Impala 28 fleet at EDYC up to 2019/20

Up until circa 2019, there were only two Impala 28 OD's based at EDYC.

Allezcat was originally raced on the Clyde with good success. Peter Cooke brought her to EDYC and raced against Stephen Lynn when he owned Impatus. Allezcat's custodianship passed to Colin and Barbara Harvey before settling in 2015 in the joint ownership of Peter Thompson and Mike Watson who renamed her Alcyone. Stephen changed Yacht from Impatus to Mipaal. (Apologies, folks, if my recollection is a little foggy or incomplete).

Up to 2019, and indeed to-date, Pete, Mike and Stephen have campaigned Alcyone and Mipal on Strangford Lough with outstanding levels of success at many SLCRA regatta's, Strangford Race Week, SLYC Frostie Series and several coastal races including the Isle of Man, Ardglass, Peel, South Rock Light-ship races etc.

Both yachts have been cruised as far afield the Scottish western Isles and throughout the Irish Sea visiting Ardglass/Carlingford Lough and Dublin Bay.

Pete was chatting with me in the boat park recently and commented, "It is great to see the fleet increasing in numbers, particularly at EDYC, with now more than 12 impala 28's on Strangford Lough. They are an excellent boat for the Lough, bridging the gap between racing and weekend cruising. It is great to see the growth of the Impala Class with now the advent of close one-design racing both at EDYC points racing and beyond. We are very much looking forward to racing in 2024."



The growth of the Impala fleet and the SLICA

Since 2020, as if a little Hunter-magic dust had been sprinkled in the boatyard, Grant/David et al brought Imp over from Largs, Scotland, John bought Beeste, followed, from Plymouth, by Maverick with Mervyn and I taking on the former, Colin bought Chorus Line, previously well raced under IRC out of Killyleagh, Gus and Keith brought Wild Mustard up from Howth, Michael bought Vela and Margie brought Romper from Newport, Wales, Mike and Georgina are bringing Trudy down to EDYC from SLYC. That makes currently 10 Impalas on the EDYC start line. Robert at SLYC gave Whistlin' Dixie a refit and paint job whilst and with Kahera, Menace and others based in the Belfast Lough and Imelda in lough Swilly and interest from Impalas in the East of ROI, we potentially have 18 for the Europeans. More on that below.

The Strangford Lough Impala Class Association (SLICA) was convened in 2020 with the intention of promoting affordable and competitive sailing of the Impala yacht on Strangford Lough and beyond. I am the current Class Captain following in the sailing-boots of Grant and Gus. Thirteen Impalas were represented at the 2024 SLICA AGM in January. The Class guickly follow Impala Class one-desian agreed to measurement constraints, rather than, for example, IRC optimized layouts, the intention being to allow for genuine first-over-the-line-racing rather than racing under the newly introduced YTC handicap rating system. We sought and have, to-date, been allocated our own start in Strangford Lough's regattas and various other events.



The yachts themselves are generally circa 40 years old and, whilst the expression "Trigger's broom" has jokingly been applied to their inventories, there undoubtably initially existed a variance in terms of the fleet's sail and hull Class-compliance. Believe me, the helms/owners are a group of strong characters and, despite or perhaps because of this, the SLICA has been able to navigate towards and is now following a common understanding as to how to maintain and upgrade our vessels in an equitable spirit.



The Impala European Championship at EDYC

You will no doubt be aware that EDYC will be hosting the Impala European Championship, incorporating the UK and Irish Nationals, on May 25th & 26th, 2024. This will include a Sonata Open Event competing on the same weekend. In addition to the two days of excellent racing (three races on the Saturday, two on the Sunday and a practice race on the Friday) there will be a daily prize giving with chill-out BBQ and music ashore after racing. Many thanks, not least to John, Peter, Gina, Gus and our RO, Ian Boggie from SLYC for the hard work put in to-date to secure and organise the event. You all are welcome to witness the unique spectacle of circa 18 Impala's in full competitive flight.
